Made by Sri. Pavithran. G, Special Tahsildar, LA General, Thrissur

Under Section 30 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013, (Central Act 30 of 2013).

Where an extent of 0.1233 Hectares of land situated in Iringapram and Thaikkad villages in Chavakkad Taluk in the District of Thrissur and registered in the name of, or occupied by the persons specified below has been declared by the Government and published in the Extra Ordinary Gazette No. 1419 Volume IX dated 12/06/2020, in the daily Mangalam dated 25/06/2020 and Metro Vartha daily dated 25/06/2020 and in the offices of District Collector Thrissur, Revenue Divisional Office Thrissur, Taluk Office Chavakkad, Iringapram and Thaikkad villages and in the affected area to be needed for the Construction of Guruvayur Railway Over Bridge. Declaration had been made for 0.1233 Hectares of land and out of which a total of 0.0382 Hectares of land is lying as "Nalath Puramboke" for which valuation has not made in the DVS.
