To ensure a free, fair, transparent and peaceful conduct of election to assembly constituencies and parliamentary constituencies, Election Commission of India has issued necessary directions in the Compendium, read as 1st paper above, to monitor / assess the Election Expenditure incurred by contesting candidates and political parties, constituting various squads / teams of officers by the District Election Officers and all such expenditure related activities are to be supervised and regularly monitored by the Nodal Officer for Election Expenditure Monitoring in District.

In connection with the General Election to the Legislative Assembly Constituencies 2021, as part of Expenditure Monitoring under guidelines of Election Commission of India Sri.Pramod.P.B., Joint Deputy Commissioner, State Goods and Services Tax, Thrissur (Mobile No: 9447786336) has already been appointed as Nodal Officer for Expenditure Monitoring during the General Election to Kerala LA Constituencies 2021 in Thrissur District, as per the Proceedings read as 3rd paper above.

As per the guidelines Election Commission of India has directed to constitute three or more Static Surveillance Teams in each LA Constituency with Executive Magistrate as head of the team and with three or more Police Personnel and one videographer.

Accordingly, Executive Magistrates for forming **three** Static Surveillance Team have been appointed for each of the 13 LA Constituencies in Thrissur District, as per the Proceedings read as 4th paper above.

Sri.M.Thamizh Vendan IRS, the Expenditure observer, appointed in respect of 64 Manalur, 69 Kaipamangalam & 66 Nattika LA Constituencies has directed to constitute three more Static Surveillance Teams in Manalur, Kaipamangalam & Nattika LA Constituencies, so
