ORDER UNDER SECTION 144 Cr.P.C.

Dated Mawkyrwat the 3rd April, 2020.

Whereas, in view of the prevailing situation concerning COVID-19 in the country and globally;

Whereas, to put in place preventive measures and awareness, to identify and take more stringent steps to ensure social distancing and home quarantine so the pandemic of COVID-19 does not spread to South West Khasi Hills District, by way of ensuring observance of strict protocols of the Advisories issued by Government of Meghalaya in the Health & Family Welfare Department,

Now, therefore, **I Kum.Isawanda Laloo, IAS, District Magistrate, South West Khasi Hills District, Mawkyrwat** in exercise of the powers conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby extend the **CURFEW** in South West Khasi Hills District with immediate effect up to **06:00AM of 6th April, 2020.**

This Order will **NOT** be applicable to the District Administration & Treasury, Security Forces and Medical Teams on duty, Wholesale & Retail Pharmacies, Police and Armed Forces, Fire & Emergency Service, MeECL, Food & Civil Supply Department, Public Works Department (PWD), Public Health Engineering (PHE) Department, Telecommunication, Banks and ATMs, petrol pumps all other essential services including Health Services, LPG Deliveries, delivery, other essential services.

Also, movement of vehicles carrying essential commodities, security forces, medical equipments and goods vehicles are also exempted. However, drivers and attendants of the vehicles shall be subject to medical screening as per laid down protocols for any other emergency a separate car pass will have to be obtained in this office.

Relaxation for market areas and regulation of the same will be informed through a separate order from this office. Any citizen /in distress/in need of essential provisions and otherwise aggrieved by this order may call District Control Room **6909904336/6033162971.**

In view of the urgency of the matter, this order is being passed exparte.
