ORDER UNDER SECTION 144 Cr.P.C.

Dated Mawkyrwat the 18th April, 2020.

In continuation to Prohibitory order under section 144 Cr.P.C issued by the District Magistrate , South West Khasi Hills District vide No.SWK/Pol-22/2012/164, Dated 15th April, 2020, and in order to put in place more preventive and mitigation measures to identify and take more stringent steps so that the COVID – 19 Pandemic does not reach or spread in South West Khasi Hills District ;

Therefore, **I Kum.Isawanda Laloo,IAS, District Magistrate, South West Khasi Hills District, Mawkyrwat** in exercise of the powers conferred upon me under section 144 Cr.P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby extend **CURFEW** in South West Khasi Hills District with immediate effect and until **6:00 AM of 23rd April, 2020** , and do hereby impose the following prohibitions :-

1. No movement of individuals or vehicles will be permitted without valid pass.
2. No inter-district travel will be permitted without valid pass.
3. No gatherings of 5 (five) or more persons in public area and premises beyond the individuals households will be permitted.
4. No moving in public places without a Mask will be permitted.
5. No spitting in public places will be permitted.

This Order will **NOT** be applicable to Security Forces, Medical Teams on COVID-19 duty, Government Officials on duty with COVID matters, Police & Armed Forces, Fire & Emergency Service, MeECL & Power Grid, Food & Civil Supply Department, FCI, Telecom, Communication & IT Services, Print & Electronic Media, Banks & ATMs, Petrol Pump, Medical Officers and staff of Health Department, Officers and staff of other Department of Government working with Corona Care Centers and Quarantine facilities and Home delivery of household items.

The following **Essential Services** are also exempted :-

Also, movement of vehicles carrying Essential Commodities along the National Highway, Security Forces and medical equipments are also exempted. However, drivers and attendants of vehicles shall be subject to medical screening, compulsory disinfection and other health advisories as per laid down protocols.
