Order:

In the Government Order 3rd read above, inter-alia, orders have been issued that the 'Destitute Differently Abled Pension Scheme (DDAPS)' shall be called 'Differently Abled Pension Scheme(DAPS)' and Unemployed persons with 40% and above disability shall be eligible under the scheme instead of disability with 60% and above consequent to the announcement made by the Hon'ble Chief Minister under 110 announcement on 20.02.2016 in the floor of the Tamil Nadu Legislative Assembly.

2. Representations from the Differently Abled Associations cited the difficulties in availing the pension due to lack of a definition of the word "Unemployed" for the grant of Differently Abled Pension as given in para 2 (iii) of the Government order third read above.

3. The Government after careful examination orders that all the unemployed Differently abled persons with 40% and above disability will be eligible to get the monthly pension of Rs.1,000/- per month except the following:-

- (i). Differently Abled Persons working in permanent jobs in Government Departments, Government Undertakings and Government Aided Institutions including Educational Institutions.
- (ii). Differently Abled Persons employed in private sector on a permanent basis and drawing regular monthly salaries, whose annual income exceeds Rs. 3.00 lakh.

- (iii). Differently Abled Persons who are self-employed and whose annual income exceeds Rs. 3.00 lakh.
