It is submitted that in the reference 2nd cited, the Hon'ble NGT has ordered to form a District Committee (As part of District Planning Committee under article 243 ZD) for preparation of District Environmental Plan to constitute a District Environment Plan covering the issues relating to Solid Waste Management, Bio-Medical Waste Management, Plastic Waste Management, Construction and Demolition Waste (C & D), 102 Non-attainment Cities, Polluted Water stretches, Polluted Industrial Clusters, Industrial Pollution Control, Utilization of treated sewage, Sand Mining and Conservation of Water Bodies at the District level and the Constitution of District Committee and District Environmental plan should be placed on the District Websites for a period of one year.
