- 1. The contractor's rate should be inclusive of all sales tax, if any which he has to pay to the Government.
- 2. No extra lead for water will be paid for any of the items and the rates should be inclusive of all such water and the contractor should make his own arrangement for soft water and power.
- 3. The contractor has to make his own arrangements for all tools and plants such as concrete mixer etc., required for the works and for the purchase of plant and machinery for the work shall release no foreign exchange.
- 4. The contractor has to make his own arrangements to procure all materials required, in sufficient quantities to confirm to standard specifications, so as to keep the progress of work continuous.
- 5. As soon as the contract is accepted, the contractor should give a programme of work, which he proposed to adopt for execution. The progress of work should be in conformity with the rate of progress specified under condition 22nd of the Tender Notice.
- 6. Contractor who has undertaken to employ technical staff should see that the technical staff is always present at site of work during the working hours, personally checking all items of works and paying extra attentions to such of those items of work which requires special attention (Viz) concrete work and RCC.
