

## OFFICE OF DISTRICT MAGISTRATE, AMBALA

### ORDER

1. Whereas, the District Ambala Disaster Management Authority is satisfied that the residents of District Ambala are threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization and has considered it necessary to take effective measures to prevent its spread in the District Ambala.

2. Whereas the MHA Govt. of India, vide its order No. 40-3/2020-DM-1(A) dated 30-05-2020 has extended the lockdown for a further period upto 30<sup>th</sup> June 2020. **I, Ashok Kumar Sharma, I.A.S., District Magistrate, Ambala invoking the powers conferred under Section 144 CrPC** do hereby prohibit the following in the interest of maintenance of public health, hygiene and safety in view of the COVID-19 pandemic.

3. Movement of any individual whatsoever for non essential purposes shall henceforth remain restricted between 09.00 p.m. to 05.00 a.m. within the district, as well as movement outward the district. Persons above the age of 65, or having co-morbidities, suffering from chronic diseases, pregnant women and children below the age of 10 years shall not come out in open except in the case of medical emergency or essential requirement as specified in the national directives.

4. The compliance of this order shall be strictly enforced and ensured by all Sub Divisional Magistrates, Executive Magistrates/Police Officers/Officials on duty in the District and any violation of the same shall be strictly dealt with as per section of 188, 269 and 270 of the Indian Penal Code, 1860.

5. The order shall be promulgated by uploading it on the District website, circulated it through WhatsApp groups, and on other medium of social/digital media. Whenever the same is not possible through these methods means of mass communication like radio, television may also be used and publicity vans be also deployed to disseminate the same.


