ORDER

Whereas, the prevailing COVID-19 pandemic is posing a threat to public health, the Government of Haryana has taken necessary steps to prevent its spread in the State of Haryana.

The Chairperson, State Executive Committee in exercise of powers under the Disaster Management Act, 2005 has authorized the undersigned to take necessary decision regarding closing of shops in such crowded areas as are deemed fit after 6.00 pm and opening of restaurants/eating places only for home delivery

Whereas, in exercise of powers vested under Disaster Management Act, 2005, the undersigned in the capacity as Chairman, District Disaster Management Authority, Ambala and in view of orders issued vide letter No. DMC-SPO-2020/4863 dated 23-04-2021 by Government of Haryana, Haryana State Disaster Management Authority, hereby orders the closing of all shops in the whole district at 06:00 PM except the pharmaceutical shops & shops dealing exclusively in grocery.

The restaurants/eating places will open only for home delivery upto 09:30 PM and will wind up the process of home delivery well before the night curfew starting at 10:00 PM.

The parks, religious places, coaching centres etc. and other public places will also close at 06:00 PM to avoid gathering at these places.

Sub Divisional Officers (C), will be the overall incharge in their jurisdiction to keep the regular surveillance of each activity and will ensure strict enforcement of this order and take action against the violator.

Sr. Superintendent of Police, Ambala, shall constitute inspection Teams for regular vigilance, for implementation of orders and also ensure wide publicity through their PCRs immediately and also to take action against the violators.

The Commissioner, Municipal Corporation/District Municipal Commissioner & District Development & Panchayat Officer, Ambala

shall also ensure meticulous compliance of the orders and arrange for wide publicity by MUNADI immediately.

The District Information and Public Relations Officer, Ambala shall give a wide publicity and disseminate the information through all modes of communication at every nook and corner of the district immediately

All the concerned are hereby ordered to comply with the directions above. Any violation of these instructions/orders is liable to criminal prosecution under section 51 to 60 of Disaster Management Act, 2005 as well as under section 188 of the Indian Penal Code, 1860.
