1. Strategize to increase sampling from vulnerable packets of the District.
2. Strategize to impose Covid Appropriate behaviours in the District.
3. Strategize to implement Guidelines issued by Union Government and State Government from time to time.
4. Implement ban of gathering of more than permitted people in social gathering/Religious Functions etc.
5. Strategize to identify and notify Dedicated Covid Care Center's in the District alongwith care of Home Isolated patients.
6. To decide upon emergency procurement of essential items required for Testing, tracing, Treating and Containing further spread of the infection in the District.
7. Any other activity needed for containment of spread of infection.

Civil Surgeon, Ambala is directed to organize weekly meeting under the Chairmanship of undersigned.
