


## OFFICE OF DISTRICT MAGISTRATE, AMBALA

### ORDER


Whereas, the District Ambala Disaster Management Authority is satisfied that the residents of District Ambala are threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization and has considered it necessary to take effective measures to prevent its spread in the District Ambala.

To contain the spread of COVID-19 in the District Ambala; the following tasks have been assigned to the officers mentioned against their names:-

S.N.	Name of the Officer	Task Assigned
1.	Chief Executive Officer, Shivalik Development Agency, Ambala	She is hereby deputed as incharge of all micro and macro containment zones in the district Ambala and she will ensure that S.O.Ps are followed with proper protocol in all containment zones. She will also suggest notifying and de-notifying of macro containment zones as per guidelines issued by the Govt. of Haryana time to time.
2.	Additional Deputy Commissioner, Ambala	He will ensure the proper functioning of the hospital beds earmarked for COVID positive patients and will ensure the additional beds wherever feasible to accommodate the additional number of COVID positive patients.




3.	Chief Executive Officer, Zila Parishad, Ambala	He will ensure that the COVID positive patients who do not have proper home isolation facilities i.e. separate room and washroom etc. should be shifted to D.C.C.C. (Dedicated COVID Care Centre). He will engage team of doctors in consultation with Civil Surgeon, Ambala for this purpose.
