

ORDER

Whereas, the District Ambala Disaster Management Authority is satisfied that the residents of District Ambala are threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization and has considered it necessary to take effective measures to prevent its spread in the District Ambala.

And whereas many persons have been tested positive for COVID-19 in the **Village-Bhurewala, Block-Naraingarh, District, Ambala** thus there being high positivity rate. In view of guidelines / advisories issued by the Government the **area Village- Bhurewala, Block-Naraingarh, District, Ambala have been earmarked as Macro Containment Zone.**

The assembly of people in these areas is strictly prohibited and the movement of persons will be restricted. The markets/shops/religious places/Choupal, Gram Sachiyalaya/Panchayat Ghar & Common Service Centre (CSC) & other public/private assembly points etc. in these areas will remain closed.

For carrying out aforementioned orders following directions are necessary to be issued:

1. To ensure the deployment of sufficient police force to restrict the entry and exit of persons in the macro containment zone and also by way of putting up Nakas to control the movements to and from the aforesaid containment zone and keep the above mentioned places closed.

(Action by : Superintendent of Police, Ambala/ DSP, Naraingarh)

2. To ensure to sanitize the entire area of containment zone and also to make necessary arrangements for disposal of solid waste from this area. Also to ensure barricading done.

(Action by : DDPO, Ambala/BDPO, Naraingarh)

3. To ensure deployment of sufficient number of teams of Doctors and Paramedical Staff for conducting door to door survey for screening of persons having SARI/Flu like symptoms throughout the macro containment zone and to keep the regular surveillance and also trace all the contacts of above persons and their family members and put them under isolation immediately.

(Action by : Civil Surgeon, Ambala /SMO, Shahzadpur)

4. To ensure uninterrupted supply of essential items to and from macro containment zone.

(Action by : DFSC, Ambala/AFSO, Naraingarh)

5. To ensure the timely supply of medicines in macro containment zone.

(Action by : Drug Controller Officer, Ambala)

6. To ensure the supply of milk etc. in containment zone.

(Action by : CEO, Vita Milk Plant, Ambala)



Sub Divisional Officer (C), Naraingarh will be overall incharge to keep the regular surveillance of every movement in the macro containment zone and ensure that no covid patients leave their homes.


All the above Officers will ensure the implementation of the above directions.

Violation of these instructions will be punishable under section 188 of the Indian Penal Code (48 of 1860) and Police Authorities are empowered to immediately arrest the violators. The compliance of this order is mandatory.
