

ORDER

In pursuance of the directions/order issued by Chief Secretary to Government of Haryana and Chairperson, State Executive Committee, Haryana State Disaster Management Authority, Chandigarh vide Memo No. DMC-SPO-2020/3093 dated 16-05-2021 and in exercise of the powers conferred upon me under section 30 and 34 of Disaster Management Act, 2005, I Ashok Kumar Sharma, IAS, District Magistrate-cum-Chairman, District Disaster Management Authority, Ambala do hereby extend the restriction imposed vide the above referred order and this office order issued vide endst No. 2086/MA dated 02-05-2021 and 2210/MA dated 10-05-2021 for another one week i.e. from **17-05-2021 (05:00 AM onwards) to 24-05-2021 (till 05:00 AM)** in District Ambala to be observed as “महामारी अलर्ट-सुरक्षित हरियाणा”(Mahamari Alert-Surakshit Haryana)”



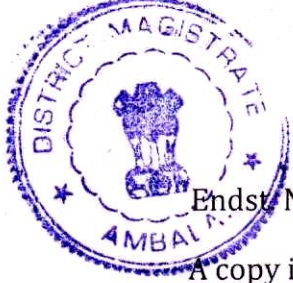
Whereas all residents of the District Ambala shall stay indoor during the above mentioned period. No person shall leave their homes or move or foot or by vehicle or travel or stand or roam around on any road or public place during the period.


All the Shops dealing exclusively in Grocery will remain open on Left/Right Basis:-

(i) All Left side shops in all MC markets. Left side Shops will be marked with “L” on the road by respective Urban Local Bodies.	(i) Monday, Wednesday, Friday and Sunday
(ii) All Right side shops in all market. Right side Shops will be marked with “R” on the road by Urban Local Bodies.	(ii) Tuesday, Thursday and Saturday

Note: Those shops which have more than one gate on different sides will declare their main gate for following the above schedule.

Any person violating these lockdown measures will be liable to be proceeded against as per the provisions of section 51 to 60 of the disaster management Act, 2005, besides legal action under sec. 188 of the IPC, and other legal provisions as applicable.


