

ORDER


In pursuance of the directions/order issued by Chief Secretary to Government of Haryana and Chairperson, State Executive Committee, Haryana State Disaster Management Authority, Chandigarh vide DMC-SPO-2020/8743 dated 09-08-2021 and in exercise of the powers conferred upon me under section 30 and 34 of Disaster Management Act, 2005, the undersigned extended the **Mahamari Alert-Surakshit Haryana** "महामारी अलर्ट-सुरक्षित हरियाणा" for a fortnight i.e. from 09-08-2021 (05:00 AM onwards) to 23-08-2021 (till 05:00 AM) vide this office order No. 3720/MA dated 09.08.2021 & 3750/MA dated 09.08.2021 in district ambala Ambala alongwith guidelines to be implemented (during the period).

Now in pursuance of Chief Secretary to Government of Haryana and Chairperson, State Executive Committee, Haryana State Disaster Management Authority, Chandigarh Memo No. DMC-SPO-2020/8969 dated 14-08-2021 and in exercise of the powers conferred upon me under section 30 and 34 of Disaster Management Act, 2005, I Vikram, IAS, District Magistrate-cum-Chairman, District Disaster Management Authority, Ambala hereby directs that the Anganwadi Centers and Creches run by Women and Child Development Department shall remain closed in Ambala District upto 31.08.2021.

District Programme Office, Women & Child Development, Ambala is hereby directed to ensure the strict implementation of this order in District Ambala..

Sub Divisional Officers (C), will be overall incharge in their jurisdiction to keep the regular surveillance of every activity and will ensure strict enforcement of this order.

Any person violating these lockdown measures will be liable to be proceeded against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, besides legal action under section 188 of the IPC, and other legal provisions as applicable.
