**ORDER**

**Dated, Kohima the 4<sup>th</sup> May 2021**

No. DCK/CON/COVID-19/2020/Pt/ :: In pursuance to Home Department order No.NSDMA-ER-COVID19/301/2020/(Pt-II) Dated 3<sup>rd</sup> May 2021 and as decided at the DTF meeting held on 4<sup>th</sup> May 2021, in view of the rapid surge in the number of persons infected by COVID-19, and with a view to curtail the transmission of the disease, **night curfew** shall be imposed in Kohima District on all days starting 5<sup>th</sup> May 2021 from 7 PM to 6 AM. However, during the curfew hours medical, emergency and essential services, including pharmacies, movement of goods vehicles through goods carriers/trucks shall be permitted.

**This Order will come into effect from 7 PM, 5<sup>th</sup> May 2021 and shall remain in force until further orders.**

Any person violating this order shall be penalised as per the provision of the Section 51 to 60 of the Disaster Management Act 2005 beside legal action under Section 188 of the IPC.
