ORDER

Dated, Kohima the 11th June 2021

No. DCK/CON/COVID-19/2020/Pt/ In exercise of powers vested under **Section 115 of the Motor Vehicle Act 1988**, movement of private vehicles shall be allowed as per '**Odd-Even**' system under the jurisdiction of Kohima Municipal Council, except on Sundays, as mentioned hereunder:

1. Odd numbered vehicles:-


On Mondays, Wednesdays and Fridays, only vehicles with registration number ending with odd numbers (Eg. 1,3,5,7,9) shall be allowed to ply.

2. Even Numbered vehicles:-

On Tuesdays, Thursdays and Saturdays, only vehicles with registration number ending with even numbers (Eg. 2,4,6,8,0) shall be allowed to ply.

Violation of this directive shall be liable to penalty under Section 177 & 179 of the Motor Vehicle Act 1988.


This Order shall be implemented with immediate effect and remain enforced till **18th June 2021** for the strict compliance of all concerned.
