Dated, Kohima the 18th June 2021


No. DCK/CON/COVID-19/2020/Pt/KR-212 :: In supersession to this office Order No. No.DCK/CON/COVID-19/2020/Pt/WR-206 , dated 17th June 2021 and in pursuance to Home Department Order No.NSDMA-ER-COVID19-301/2020 (Part-II)/5460, dated 16th June 2021 and in continuation to this office order No.DCK/CON/COVID-19/2020/Pt/WR-125(A) dated 11th June 2021, the existing lockdown measures shall continue to remain in force in Kohima District till 30th June 2021, with the following additional directives as given hereunder:

1. Permitted shops and business establishments shall be allowed to be open on all days from 06:00 AM to 02:00 PM. However, Hardware and Electrical shops, shops selling stationeries, mobile phones and computer accessories, garages for automobile repairing and shops selling vehicle spare parts shall be allowed to open only on **MONDAY, TUESDAY, THURSDAY AND FRIDAY** from 06:00 AM to 02:00 PM.
2. It is reiterated that the proprietor of permitted category of business establishments/ private establishments will be held responsible for ensuring strict compliance to COVID-19 SOPs within their respective establishments.
3. There shall be a **TOTAL BAN** on the movement of individuals/vehicles from 4:00 PM to 5:00 AM everyday from 19th June till 30th June 2021 across the district except for reasons/purposes and for those who are permitted to move as per the existing lockdown measures.
