No. DCK/CON/COVID-19/2020/Pu WK - 158 (A) :: In continuation to this office order of even number Dated 17/07/2021, 'Odd-Even' system for movement of **private vehicles** is hereby implemented under Kohima Municipal area as per Section 115 of the Motor Vehicle Act 1988, on all days except Sundays, as mentioned hereunder:

1. Odd numbered vehicles:-

On Mondays, Wednesdays and Fridays, only vehicles with registration number ending with odd numbers (Eg. 1,3,5,7,9) shall be allowed to ply.

2. Even Numbered vehicles:-

On Tuesdays, Thursdays and Saturdays, only vehicles with registration number ending with even numbers (Eg. 2,4,6,8,0) shall be allowed to ply.

Violation of this restriction Order will be liable to be penalised under Section 177 & 179 of the Motor Vehicle Act, 1988.

This Order shall be implemented with immediate effect and shall remain enforced till 18th August 2021 for the strict compliance of all concerned.
