Sub: Precautionary measures for avoiding fire incidents.

ORDER NO 83 DM/Ktr of 2018

D A T E D : 27 . 10 . 2018 .

1. Whereas, it has been generally observed that villagers residing in far flung areas of Distt. Kishtwar likely hilly areas of Tehsil Paddar/Machail/Marwah/Warwan/Chhatroo/Chingam/Drabshalla/Nagseni & Bonjwah are usually dumping the dry grass/hayrick nearby residential houses as fodder for four-footed animals for winter season.
2. Whereas, it has been observed that main cause of fire incidents which oftenly occurred in District Kishtwar is due to storage of dry grass/hayrick inside or nearby residential houses as the dry grass is equal to Gun powder to catch easily fire .
3. Whereas, the villagers also burns the fire-wood in side the Cow sheds during winter season to keep the Cow shed and four-footed animals warm in order to save from cold in snow land/hilly areas and the Cow sheds are commonly made of timber.
4. Whereas, there is no Fire & Emergency services water Tender facilities in hilly & far flung areas of Distt. Kishtwar to extinguish the fire incidents .
5. Whereas, in past major fire incidents occurred in several places like i. fire incident of village Kadelu in Paddar Tehsil in which four persons of a family died on spot ii. Fire incident of village Sazzar in Paddar Tehsil iii. Fire incident of village Ungai in Paddar Tehsil iv. Fire incident of village Margi in Warwan Tehsil v. Fire incident of village Sukhnai in Warwan Tehsil vi. Fire incident of village Choidraman in Warwan Tehsil, after investigation it was established that cause of fire is due to storage of dry grass nearby residential houses resulted loss of human lives and property worth in crores in the said fire incidents.

6. Whereas, in order to save the life and property in hilly areas from such type of fire incidents, it is expedient to take precautionary measures for safeguarding the life and property in the hilly areas of above mentioned Tehsils restriction/ban is necessary :-

Therefore, keeping in view the above mentioned facts, I, Angrez Singh Rana (KAS) District Magistrate Kishtwar in exercise of the powers conferred upon me under Section 144 Cr.P.C do hereby impose ban/restriction for storage/dumping of dry grass / hayrick in/on or nearby residential houses as fodder for four footed animals for winter season . No person/individual shall be allowed to store dry grass within 100-meter radius of the Residential house or village.

The concerned Tehsildar/SHO will personally implement the Order in letter and sprit.

Issued today on 27th of October 2018 under my seal and signature and shall remain enforce for a period of two months from the date of its issuance .
