**Subject :- Loksabha Elections 2019- Issuance of Election Duty Certificate regarding.**

**CIRCULAR**

During the course of ongoing Lok Sabha Elections 2019, a number of Govt employees /Police Persons/ Drivers/Cleaners/Photographers etc have been put on Election duties. The Election Commission has issued instruction with regard to the voting of all persons who are registered voters and if the person is deployed on Election duty within the same constituency, he is entitled for Election Duty Certificate(EDC)

As such, the Assistant Returning Officer AC- 51 Kishtwar and AC-52 Inderwal are hereby enjoined upon to distribute application forms (12A) for issuance of EDC as prescribed by the Election Commission of India to all the employees during the 2<sup>nd</sup> phase of training and communicate the same to the concerned Electoral Registration Officer (ADC/ACR Kishtwar) for the purpose of marking in the respective Electoral Roll against the name of elector /Person to whom EDC is issued. The EDC shall be distributed to all such person employees on the Second day of training of polling parties enabling them to cast their vote at the polling station where they are deployed on election duty on poll day.

Further it is impressed upon all the Govt. Employees who are to be deployed as Presiding Officer /Polling Officers/Zonal /Sectoral Magistrate/Police Personnel/Drivers /Cleaners/Photographers and other attached Govt. employees shall apply through EDC for greater participation in Electoral process well in advance.
