**Advertisement Notice for Hiring Services of 02 Registered Pharmacists to run "Pradhan Mantri Bhartiya Jan Aushadhi Kendra" (PMBJAK) at District Hospital Kishtwar, on profit sharing basis.**

Applications are hereby invited from eligible registered Pharmacists to work on profit share basis, in Pradhan Mantri Bhartiya Jan Aushadhi Kendra (PMBJAK) to be set up at District Hospital Kishtwar.

**Eligibility Criteria:**

1. The applicant must be a permanent resident of J&K State and preferably residing in District Kishtwar and possessing a valid Diploma in Pharmacy from SMF of any other recognized institute.
2. The candidate shall be a Pharmacist registered with J&K Pharmacy council. Preference shall be given to the candidates having diploma in Pharmacy or higher related qualification from recognized institute.
3. Maximum age limit of the applicant shall be 40 years (candidates more in age, shall be preferred over the younger candidates).
4. He / She shall have working knowledge of operating computer for billing purpose.
5. The applicant should be unemployed for which the candidate shall have to give an undertaking to this effect on stamp paper duly attested by a 1<sup>st</sup> class Judicial Magistrate.

**Terms & Conditions:**

1. PMBJAK shall run on 24x7 basis under the supervision of Medical Superintendent Distt. Hospital Kishtwar.
2. Only Medicines supplied by the Bureau of Pharma PSUs of India (BPPI) shall be sold at PMBJAK and all the billing should be done only by using the software provided by BPPI.
3. Out of Total 20% margin on MRP of each drug as per guideline, registered Pharmacists shall be provided 15% (i.e. each Pharmacist-7.5%) of margin on MRP of each drug and rest of the 5% of the margin shall go the HDF of DH Kishtwar.
4. Engagement of Pharmacist in PMBJAK is a temporary arrangement for 03 years on performance basis and the department / committee shall be well within its powers to terminate the services of registered Pharmacist any time without any notice in case of unsatisfactory performance and substitute him/ her with selection of another registered Pharmacist.
5. The continuation of services of the registered Pharmacist shall not confer any right for the candidate's permanent absorption / regularization in the department.
6. The selected Pharmacists shall execute an agreement with the department through Medical Superintendent DH Kishtwar, duly attested by the 1<sup>st</sup> Class Judicial Magistrate, that the candidate will abide by all the terms and conditions as laid by the department and shall work under the supervision of the Medical Superintendent DH Kishtwar. Further the candidate shall not claim any appointment / regularization in the department in lieu of this agreement.

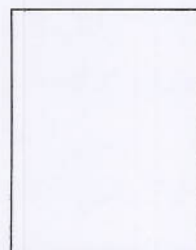
