- i) Whereas, taking cognizance regarding prevailing health emergency of Noval Corona Virus (COVID-19) which has resulted in many cases in UT of J&K, various orders/advisories have already been issued by this office wherein the public was advised to refrain from venturing outside in large numbers and avoid mass gathering, crowds, congregations, functions etc; and
- ii) Whereas, necessary precautions with regard to prevention and control of Noval Corona Virus (COVID-19) have already been undertaken by the District Administration in co-ordination with Police & Health authorities; and
- iii) Whereas, COVID-19 has pattern of transmission of rapid rate, in case prescribed preventive protocols including avoiding mass gathering etc are not strictly followed.

Now, therefore, in view of the above mentioned facts, I, **Rajinder Singh Tara, KAS, District Magistrate, Kishtwar** in exercise of the powers vested in me under Section 144 of Cr.P.C do hereby impose ban on movement of individuals for all non-essential activities between **7:00 PM to & 7:00 AM** in the entire Kishtwar District which includes Kishtwar Town and its adjoining areas with immediate effect till the restrictions are in place. Any violation of this order by any person shall invite action under IPC.
