ORDER

1. Whereas, construction of Pakal Dul hydro Electric Project has been allotted to M/S AFCON JAL JOINT VENTURE, M/S JP ASSOCIATE Ltd. and M/S L.N.T Ltd. and construction of Keru HEP has been allotted to M/S Patel Engg. Ltd. by the concerned CVPP authorities; and
2. Whereas, there are frequent complaints from the executing Agencies that some miscreants are misleading and instigating the concerned youth / Zamindars / public of the area to get ready for agitation / hartals against the Management of the Project and have created hindrances in construction work of the power Project at several places; and
3. Whereas, it is further reported that some of the locals youth with the help of some miscreants have been causing hindrances in the smooth execution of work by making demonstrations at different places of the power projects; and
4. Whereas, the management of the Project has reported that some youths / locals have created sense of insecurity and fear in minds of Management and have vitiated the peaceful environment in the area as a result of which the construction work of the Power Project has been hampered; and
5. Whereas, for smooth construction of Power Project work and maintenance of proper law and order, peace and tranquility at construction sites i.e i. Residential Quarters of AFCONS, L.N.T, to Pakal Dul Power House site including official site of Afcons/ L.N.T, Tamruchi, Aarzi and Tanji ii. Power Project site in Dangooru and Sourbatti area in Dachhan including residential quarters and official sites of M/S JP ASSOCIATE Ltd. iii Power Project Sites in Keru including residential quarters and official sites of M/S Patel Engg.Ltd. Prohibitory Orders under Section 144 Cr.P.C is hereby imposed regarding:
 - i. Assembly of five or more persons at above mentioned places/locations is prohibited.
 - ii. No one shall join or take out any procession or hold public meeting of five or more persons or raise slogans likely to pose threat to construction work or injure the feeling of others at above mentioned places/locations.
 - iii. No one shall carry any weapon including Dandas, Lathies, Stone etc. at above mentioned places/locations.

Issued today on 23rd of March 2021 under my hand and seal and shall remain enforce for a period of two months from the date of its issuance.
