
**Notice Inviting Quotations (2<sup>nd</sup> call) for supply of Biometric Device**

- 2) The rates shall have to be quoted only in the prescribed format mentioned in Annexure-I for supply of Biometric device.
- 3) The supplier shall specify the warranty period and condition of after sales service in his quotation. The supplier shall provide resolution of the technical problems occurring during Device in operation
- 4) The Block Development Officer Dukli RD Block has got right to accept or reject one or all the quotations without assigning any reasons.
- 5) The Block Development Officer Dukli RD Block is not responsible for any delay in receipt of quotation sent by post/courier. The parties can submit the quotation at the Office of the Block Development Officer Dukli RD Block, West Tripura District on or before the due date and obtain the acknowledgement.
- 6) The payment will be made after 30 days on satisfactory performance of Supplied Biometric device. No advance payment shall be made. The payment after the applicable deductions shall be made by crossed cheque only.
- 7) Any other conditions stipulated at the time of the placing the Orders have to be complied with.
- 8) In the event of any dispute the sole arbitrator will be the DM & Collector, West Tripura District, Agartala or any other officer appointed by him whose decision shall be final & binding on both the parties.
