MEMORANDUM

Sub:- Restriction on use of State Guest House, Circuit House, Dak Banglows, etc. in connection with General Election to Lok Sabha 2019 -regarding.

To ensure conduct of General Election to Lok Sabha, 2019 in a free, fair and transparent manner, all concerned are hereby informed that:-

1. No State Guest House, Circuit House, Dak Banglows, etc. shall be monopolized by the party in power or its candidates and such accommodations shall be allowed to other parties and candidates in a fair manner.
2. No party or candidate shall use or be allowed to use such accommodation including premises appertaining thereto as a campaign office or for holding any public meeting for the purpose of election propaganda.
3. The State Guest House, Circuit House, Dak Banglows, etc. can be used only for temporary stay (boarding & lodging) during transit of such functionaries and their use should restrict to that purpose only.
4. No casual meetings by member of political parties inside the premises of such Government accommodations are permitted and any violation of these shall be deemed to be a violation of Model Code.
5. Only the vehicle carrying the person allotted accommodation in the State Guest House, Circuit House, Dak Banglows, etc. and more than two other vehicles, if used by the person, will be permitted inside the compound of such accommodations.
6. Rooms should not be made available for more than 48 hours to any single individual.
7. There will be freeze on such allocation from 48 hours before the close of poll till completion of poll or re-poll.
8. The Political functionaries who are provided security in Z scale or above or equivalent by various State /Central Government shall be provided accommodations on equitable basis. This shall be subject to the condition that such accommodations is not already allotted or occupied by Election related officials or Observers. No political activity can be carried out by any political functionary in such accommodations.

All concerned are therefore, requested to kindly adhere to the above guidelines of Election Commission of India strictly.


