9. The Sub Divisional Magistrate, Belonia (ARO) -Member


The committee so formed shall have two distinct functions

- (i) Certification of Advertisement

The Committee shall monitor

1. Political advertisement in electronic media
2. Political advertisements in other media, either overt or covert, from expenditure monitoring angle
3. Advertisement in print media
4. Checking of the need and address of the publishers and the Printers is listed on any election pamphlet, poster, handbill and other documents as required U/S 127 A of R.P. Act. 1951. The Committee will submit a report to the Accounting Team on daily basis with copy to the Returning Officer and Expenditure Observer in respect of each candidate in the prescribed format (as per Annexure – 12 of Expenditure guidelines). A copy of the same shall also be endorsed to the Additional Chief Electoral Officer, Tripura.


