WHEREAS, Preliminary Notification **NO. F. 09 (03)-REV/ACQ/VI/14**

dated the 01-03-2018 under Sub-Section 1 of Section 11 and subsequently, Declaration **NO. F. 09**

(03)-REV/ACQ/VI/14 dated the 22-06-2018 Under Section 19 of "the Right to Fair

Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013", relating to the land/lands measuring 0.8140 acres in Mouza Dukli Sheet No. 1 (5)/P of Dukli Tehsil was issued by the Government.

AND WHEREAS, the possession of entire land measuring 0.8140 acres has not been taken over by the Government as, the land in question is no longer needed by the Requiring Department;

NOW, THEREFORE, in exercise of the power conferred by Sub-Section (1) of Section 93 of "the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" the Government hereby withdraws from the acquisition of the said land/lands as described in the schedule below.
