General Terms and Conditions:-

1.Earnest Money @ 2.5% of the reserve value put the Auction **without ceiling limit** on any Nationalized bank guaranteed by the Reserve Bank of India should be deposited in the shape of **“Deposit at Call” / “Fixed Deposit”** in favour of the Senior Deputy Magistrate (HOO/DDO), DM's Office, West Tripura having validity not less than 6 (Six) months. **The Earnest Money must be submitted along with the auction bid document.** Earnest Money in any other form will not be accepted **Bid without Earnest Money will be declared as informal.**

2.Auction Bid Form with details terms & conditions can be obtained on submission of prayer along with self attested copy of PAN CARD, AADHAAR Card Enlistment or Labour license on payment of **Rs.100/- (Rupees One hundred)** only in the shape of **‘Demand Draft’ (Non refundable)** from Nazarat Section, office of the District Magistrate & Collector, West Tripura District on or after 06/03/2020 during office hours on all working days up to 4.00 P.M. of 16/03/2020 .

3. If the office happens to be closed on the date of receipt / opening of the Auction Bid as specified, the next working day with the same time and venue will be considered.

4. The bidder shall quote the rate & amount, both in words as well as in figures.

5. Only the highest bidder (first highest) for the Auction will be selected.

6. The Earnest Money of the successful bidder, (first highest bidder) who refuses to undertake the contract after final selection, shall be forfeited. Earnest Money (without any interest) of unsuccessful bidder will be released after finalization of the Auction process.

7. The authority reserved the right to declare the Auction process cancelled, at any time without assigning any reason thereof.

8. Canvassing in connection with Auction Bid is strictly prohibited and the bidders **who resort to canvassing** will be liable for rejection.

9. The bidder shall read the terms & conditions, specifications and special conditions etc carefully before submitting the bid.

10. No labour under 14 years age shall be employed in the work and all labour employed shall be paid at the rates not less than those approved by the Government of Tripura will be binding on the Agency and bidder should abide by the Labour rules as applicable.

11. All tools, plants and instruments etc. required for the work will have to be arranged by the agency at his/her own cost and risk.

12. Photocopy of Valid Enlistment or Labour license, Pan Card, AADHAAR Card shall be submitted along with the Auction Bid.

(All such documents should be attested either by a Gazatted Officer of the central Government or by Notary and shall also be self-authenticated by the bidder).

SPECIAL TERMS & CONDITION

1. The successful agency shall be required to deposit the full amount of value put to Auction within 7 (seven) days from the date of issue of communicating the acceptance of the bid failing which is earnest money deposited with the bid shall be fully forfeited.
2. The Agency shall have to clear old foundation work and level & neatly clear the demolition site after completion of his/her work and hand over the site to the concerned authority or his authorized representative.
3. The security money shall be released on issue of clearance certificate by Engineer-in-Charge after successful completion of the works.
4. If any debris is found at the site of work after completion of the Agency shall have to remove all such debris from that site and neatly dress and level the site per terms & conditions, otherwise the cost for such clearing of site will be deducted from the deposited Security money of the bidder by the authority.
5. If any unrealistic and willful delay of work on the part of the Agency is observed by the Authority, a lump sum fine shall be imposed @ **Rs.50 (Rupees Fifty) only** per day subject to maximum of security money. Such amount shall be deducted from the security money of the bidder deposited in favour of the Sr. Deputy Magistrate (HOO / DDO), DM's Office, West Tripura District.
