MEMO

Whereas, based on the Advisory issued by the Health & Family Welfare Department, Government of Tripura vide No.F.13(13-132)-DFWPM/DSP/2020(Sub) dated 10/03/2020 and the subsequent memorandum issued Home Department vide No.F.21(29)-PD/2007 dated 16.03.2020, the State Government of Tripura had decide that in the interest of **human lives and safety in the state to avoid mass gathering of persons at all cinema halls, gymnasiums and swimming pools are to be closed up to 31st March,2020 for preventive measure.**

Whereas, "**Corona virus**" is declared as pandemic by WHO. Therefore in order to ensure safety of people of West Tripura District, I am fully satisfied that there are sufficient reason/ grounds for passing prohibitory orders U/S-144 of Criminal Procedure Code (Cr. P.C), 1973 to ensure that there is no danger to human life, health or safety.


Therefore, **I Dr. Sandeep Mahatme, IAS**, District Magistrate & Collector, West Tripura power conferred upon me U/S-144 of the Criminal Procedure Code, 1973 with a views to prevent danger to human life & safety do hereby promulgate and order U/S-144 of the Cr. P.C in the West Tripura District, prohibiting the conduct of the mass gathering of person at all cinema halls, gymnasiums and swimming pools in West Tripura District(more than five person at one place).

This order shall come into force in the area under West Tripura District w.e.f **16/03/2020 and ending at 2400 hours on 31/03/2020** unless withdrawn earlier.

Any person contravening this order shall be punishable U/S- 188 of the Indian Penal Code.
