MEMORANDUM

The Ministry of Home Affairs its order **40-3/2020-DM-I(A)** dated **1st May,2020** has directed that the lockdown measures will be continued to be implemented in all part of the Country for a further period of 2(two) weeks w.e.f. **04/05/2020 to 17/05/2020**.


Hence, it is imperative to enforce the lockdown measures and simultaneously regulate the marriages related social gatherings, so that the spread of COVID-19 can be contained in the West Tripura District.

As per directives of the MHA, the following conditions needs to be fulfilled before obtaining formal approval of the DM & Collector, West Tripura District for solemnising marriages in West Tripura district:

1. Maximum number of guests allowed in all marriage gatherings **shall not be more than 50(fifty)**.
2. Inter-district movement of guests is prohibited.
3. No person(s) from Red zone (Hotspots) district will be allowed to enter West Tripura district without obtaining formal permission of the DM & Collector of the concerned district. The copy of the permission should be supplemented with the application in original.
4. Disinfectant Certificate from the proprietor of the concerned Marriage Community hall must be obtained and submitted along should be submitted along with the application.
5. In case of marriages being solemnised in the applicants' residence, sanitization of the entire house, common facilities and all points which come into human contact e.g. door handles etc should be done.
6. Only 5 LMVs are permitted for each applicant for a maximum period of 2 days only. (On receiving approval Separate passes will be issued by the Nazareth Section, DM's Office, West Tripura).
7. Light Motor vehicles (LMV) are permitted to have maximum two passengers beside the vehicle driver; for 2 wheelers pillion rider is not allowed.
8. Wearing of face cover is compulsory in all public places including marriage halls.
9. Provision for hand wash, sanitizer preferably with touch free mechanism will be made available at the entry & exit points and common areas of the marriage hall.
10. Sufficient quantities of hand wash and sanitizer shall be made available at the marriage ceremony hall.
11. The movement of individuals, for all non essential activities, shall remain strictly prohibited between **7 pm to 7am**.

For the sake of regulating the marriage related gatherings in West Tripura District all concerned are hereby instructed to obtain formal permission from the undersigned by submitting an application in the following format either in person or through e-mail to the following e-mail ids- **noemwest2019@gmail.com** / **disasterdmwest@gmail.com**

Any person violating these lockdown measures will be liable to be proceeded against as per the provision of Section 51 to 60 of the Disaster Management Act, 2005 besides legal action under Section 188 of the IPC and other legal provisions as applicable.
