ORDER UNDER SECTION 144 Cr.P C

Whereas, it has been made to appear from the order issued by the Home Secretary to the Government of India, vide its communiqué **No.40-3/2020-DMI(A)** dated **01/06/2020** and **subsequently issued by the Chief Secretary, Government of Tripura vide his order No.F.2(1)CS/HOME/2020 dated 31/05/2020** that the lockdown measures for containment of COVID-19 pandemic in the West Tripura district has been further continued for 30(thirty) days more i.e upto 30/06/2020.

Whereas "COVID-19" is declared as pandemic by the WHO, and to combat the deadly disease from community spreading and to ensure safety of people residing in West Tripura District, I am fully satisfied that there are sufficient reasons/grounds for passing prohibitory orders U/S- 144 of Criminal Procedure Code (Cr. P.C), 1973 to guarantee that there is no assembly of 5 or more persons in public places.

Now Therefore, I **Dr. Mahatme Sandeep Namdeo, IAS, District Magistrate & Collector, West Tripura** with an objective to minimize the threat of Corona Virus (COVID-19) and maximize public safety, in exercise of the powers vested with me Under **Section 144 Cr. P.C.** do hereby direct the citizens residing in West Tripura District comply with the following instruction:-

1. Prohibition on the assembly of 5 or more person within West Tripura District.
2. Prohibition of all Social/Political/sports/entertainment/academic /Cultural/religious functions/ other gatherings and large congregations within West Tripura.
3. Prohibition on the functioning of Cinema halls, gymnasium, swimming pools, entertainment parks, theatres, bars and auditoriums, assembly halls and similar places.
4. The activities in religious places/places of worship for public will be allowed with effect from **8th June, 2020**, except in the containment zones and until further orders.
5. The functioning of Hotels, restaurants, other hostility service and shopping malls will be allowed with effect from **8th June, 2020**, except in the containment zones and until further orders.
6. Prohibition and restriction on the handling or transporting any kind of weapons, licensed or otherwise.
7. The movement of individuals for all **non-essential activities shall remain strictly prohibited between 9:00 PM to 05:00 AM.**
8. **Wearing of face cover/masks** is compulsory in all places and adequate stock of such face covers shall be made available.
9. **Prohibition of spitting and urinating in public spaces and work places is a punishable offence and will be penalised.**
10. Shops will ensure maximum six feet distance (two gaz ki doori) among customers and shall not allow more than 5 persons at the shop

This order shall continue to remain in force with effect from **2100 hours** on **01/06/2020** and shall be effective for a period of **30 days** up to and including **30/06/2020**.

Any person or persons found to violate this order shall be punishable under section 188 IPC, 1860.


