MEMORANDUM

With an objective to check the spread of COVID-19 and to prevent the community transmission of COVID-19, the Chief Secretary to the Government of Tripura in the capacity of the Chairman of the State Executive Committee of Tripura State Disaster Management Authority has ordered to enforce "**Total Lockdown**" within 1.00 KM of International Bangladesh border in Rural areas and 0.50 KM in Municipal areas within the West Tripura District for 7 days **w.e.f. 7.00 AM of 17.07.2020 (Friday)** which has been issued Vide No.F.2(1)/CS/HOME/2020 dated 14 July, 2020.


NOW, Therefore in exercise of powers vested upon me as the District Disaster Management Authority, under **Section 26** of the **Disaster Management Act, 2005**, the following border areas in West Tripura has been demarcated to enforce totally lockdown **within 1.00 KM of International Indo-Bangladesh border in Rural areas** and **0.50 KM in Municipal areas** in the West Tripura District for **7 days w.e.f. 7.00 AM of 17.07.2020**.
