
**ORDER UNDER SECTION 144 Cr.P.C**

**Whereas**, it has been made to appear from the order issued by the **Chief Secretary to the Government of Tripura vide its order No. F.2(1)CS/H&FW/2020 dated 31/08/2020** that the Unlock Measures for containment of COVID-19 pandemic in the West Tripura district has been further continued w.e.f. **01/09/2020 to 30/09/2020**.

**Whereas "COVID-19"** is declared as pandemic by the WHO, and there is a recent spurt in the spread of COVID-19 in West Tripura District specially Agartala Municipal Corporation area. It is felt that unless measures are put in place to contain the spread of Pandemic, there is a chance of large scale spread of COVID-19 which is likely to cause loss of human lives.

Now, Therefore, I, **Dr. Shailesh K. Yadav, IAS, District Magistrate & Collector, West Tripura** with an objective to minimize the threat of Corona Virus (COVID-19) and maximize public safety, in exercise of the powers vested in me Under Section 144 Cr.P.C do hereby direct the citizens residing in West Tripura District to comply with the following instructions:-

1. Night Curfew will be imposed till 30<sup>th</sup> September, 2020 for the period from 9 PM to 5 AM except that for Agartala Municipal area where the Night Curfew will be from 8 PM to 5 AM.
2. Prohibition on the assembly of 10 (ten) or more person within West Tripura District (outside containment zones), except for Police & Security forces on duty.
3. Prohibition of all Social/Political/sports event/entertainment/academic /Cultural/religious functions/ other gatherings and other congregations within West Tripura.
4. Prohibition on the functioning of Cinema halls, Swimming pools, entertainment parks, theatres and auditoriums, assembly halls and similar places.
5. The activities in religious place/places of worship for public will be allowed with minimum number of persons except in the containment zones and until further orders.
6. All the schools, colleges, educational & coaching institutes etc shall remain closed till **30<sup>th</sup> September, 2020**. However, relaxation in terms of separate order issued by Education Department in this respect will apply.
7. The functioning of Hotels, restaurants, other hostility service and shopping malls will be allowed in accordance with SoP issued by MOHFW dated-04/06/2020, except in the containment zones and until further orders.
8. Prohibition on the handling or transportation of any kind of weapons, licensed or otherwise except for Police & Security forces on duty.
9. The movement of individuals for all non-essential activities shall remain strictly **prohibited between 09:00 PM (night) to 05:00 AM (morning)** except in Agartala Municipal area where it will be prohibited between **8 PM to 5 AM**.
10. **Wearing of face cover/masks** is compulsory in all public places .
11. **Spitting and urinating in public spaces and work places is prohibited and is a punishable offence and will be penalized.**
12. Shops will ensure minimum six feet distance (two gaz ki doori) among customers and shall not allow more than 5 persons at the shop.

This order shall continue to remain in force with effect from zero hours on **01/09/2020** and shall be effective till **30/09/2020**.

Any person or persons found to violate this order shall be punishable under section **188 IPC, 1860**.

The order shall be promulgated by affixing copies thereof on the notice Board of the office of the undersigned and publication in newspapers having circulation in the District through the Director, ICA Deptt., Government of Tripura.
