ORDER

(Under the Disaster Management Act, 2005)

The Chief Secretary, Government of Tripura vide its order F.2(1)/CS/Home/2020 dated 01/10/2020 has issued guideline for re-opening more activities outside of the Containment Zone which will remain in force up to 31/10/2020.

Hence, it is imperative to enforce the unlock measures and simultaneously regulate the marriages related social gatherings, so that the spread of COVID-19 can be contained in the West Tripura District.

As per directives of the Chief Secretary, the following conditions needs to be fulfilled before obtaining formal approval of the DM & Collector, West Tripura District for solemnizing marriages in West Tripura District.

1. Maximum number of guests allowed in all marriage gatherings shall not exceed fifty.
2. Person from containment zone shall not be allowed to attend such functions.
3. No person should be allowed to enter the marriage hall without thermal scanning, sanitization and mask etc.
4. Anyone found having fever (33.50C or 99.50F) cold, cough, and difficulty in breathing shall not be permitted to attend the function and immediately referred & seek medical advice.
5. Frequent sanitization of all points which come into human contact e.g door handle etc. shall be the responsibility of marriage/ banquet hall/ house owner.
6. All staffs and helpers of marriage/ banquet hall etc. shall use face mask, gloves etc. during the whole function period.
7. Parking of vehicles shall be managed by the owner in such a manner that proper social distancing is maintained.
8. Consumption of liquor, paan, gutkha, tobacco etc. is not allowed.
9. A Nodal person shall be identified for overseeing the arrangement and co-ordination at the venue by the owner and his/her contact details to be shared with the District Administration.
10. Provision for hand wash, sanitizer preferably with touch free mechanism will be made available at the entry & exit points and common areas of the marriage hall.
11. All guests should have downloaded the Arogya Setu App.


For the sake of regulating the marriage related gatherings in West Tripura District all concerned are hereby instructed to obtain formal permission from the undersigned by submitting an application in the prescribed format either in person or through the following e-mail address- sectionjudicial@gmail.com.

Any person violating these unlock measures will be liable to be proceeded against as per the provision of Section 51 to 60 of the Disaster Management Act, 2005 besides legal action under Section 188 of the IPC and other legal provisions as applicable.

The Superintendent of Police, West Tripura and all the Sub-Divisional Magistrates. of West Tripura District in their respective jurisdiction shall ensure strict enforcement of the order.

The DIO, West Tripura is hereby directed to upload the contents of the order in the District website.

The order will take immediate effect.
