NOTIFICATION



Whereas, it is felt necessary to keep all the foreign liquor shops and Country liquor shops including Bar premises closed with effect from 23-10-2020 to 26-10-2020 & on 14-11-2020 under West Tripura District for ensuring public peace, tranquility and maintenance of law and order during "Durga Puja" & "Diwali" (Kalipuja).

Now, therefore, in exercise of powers conferred under Rule 174 -A (e), (g) of the Tripura Excise Rules 1990, the undersigned do hereby order that all the foreign liquor shops and country liquor shops including Bar premises under West Tripura District shall remain closed with effect from 23-10-2020 to 26-10-2020 & on 14-11-2020 and should be strictly observed "Dry Day".

Any violation of the aforesaid order will invite stera action.


