**ORDER**

**(Under Disaster Management Act, 2005)**

The Chief Secretary, Government of Tripura vide its order F.2(1)/CS/Home/2020 dated 29/10/2020 has issued guideline for re-opening more activities outside of the Containment Zone which will remain in force up to 30/11/2020.

Whereas, the Chief Secretary, Govt. of Tripura in its order as highlighted above has continued with the prohibition which includes funeral/last rites related gathering and accordingly it has been restricted with limited person.

Whereas, in conformity with the guidelines, the following regulations are hereby notified for performing funeral/last rites in west Tripura District **up to 30/11/2020**.

1. Maximum number of guests allowed in all venue of the funeral/last rites gatherings shall not exceed **twenty**.
2. Person from containment zone shall not be allowed to attend this funeral/last rites.
3. No person should be allowed to enter the venue of the funeral/last rites without thermal scanning, sanitization, masks etc.
4. In case of Funeral Ceremony (Sradha) to be organized in the applicants' residence, sanitization of the entire house, common facilities and all points which come into human contact e.g. door handles etc should be done by using sodium hypochlorite solution.
5. Wearing of face cover is compulsory in all public places including the halls where funeral ceremony is organized.
6. A Nodal person shall be identified for overseeing the arrangement and co-ordination at the venue by the owner and his/her contact details to be shared with the District Administration.
7. Provision for hand wash, sanitizer preferably with touch free mechanism will be made available at the entry & exit points and common areas of the marriage hall.
8. All guests should have downloaded the Arogya Setu App.


Any person violating these aforesaid measures will be liable to be proceeded against as per the provision of Section 51 to 60 of the Disaster Management Act, 2005 besides legal action under 188 of the IPC and other legal provisions as applicable.

The Superintendent of Police, West Tripura and all the Sub-Divisional Magistrate of West Tripura District in their respective jurisdiction shall ensure strict enforcement of the order

All the persons residing in West Tripura District must comply with the aforesaid regulations. Any violation of the aforesaid instructions will invite stern action.

The order will take immediate effect.
