ORDER

(Under Disaster Management Act, 2005)

The Chief Secretary, Government of Tripura vide its order F.2(1)/CS/Home/2020 dated 04/02/2021 has issued guideline on COVID-19 for Surveillance, Containment and caution for more activities outside the Containment Zone which will remain in force up to 28/02/2021.

Whereas, the Chief Secretary, Govt. of Tripura in its order as highlighted above has regulated all social gathering which includes funeral ceremony/last rites related gathering and accordingly it has been restricted with up to 50% capacity of the venues and with a ceiling of 200 persons.

Whereas, in conformity with the guidelines, the following regulations are hereby notified for performing funeral/last rites in west Tripura District up to 28/02/2021.

1. Maximum number of guests allowed in all venue of the funeral ceremony /last rites gatherings up to 50% capacity of the venues and with a ceiling of 200 persons.
2. The organizers will deploy sufficient number of volunteers/staffs to regulate the crowd.
3. Person from containment zone shall not be allowed to attend this funeral/last rite.
4. No person should be allowed to enter the venue of the funeral/last rites without thermal scanning, sanitization, masks etc.
5. In case of Funeral Ceremony (Sradha) to be organized in the applicants' residence, sanitization of the entire house, common facilities and all points which come into human contact e.g. door handles etc should be done by using sodium hypochlorite solution.
6. Wearing of face cover is compulsory in all public places including the halls/venues/places where funeral ceremony is organized.
7. A Nodal person shall be identified for overseeing the arrangement and co-ordination at the venue by the owner and his/her contact details to be shared with the District Administration.
8. Provision for hand wash, sanitizer preferably with touch free mechanism will be made available at the entry & exit points and common areas of the marriage hall.
9. All guests should download the Arogya Setu App.


Any person violating these aforesaid measures will be liable to be proceeded against as per the provision of Section 51 to 60 of the Disaster Management Act, 2005 besides legal action under 188 of the IPC and other legal provisions as applicable.

The Superintendent of Police, West Tripura and all the Sub-Divisional Magistrate of West Tripura District in their respective jurisdiction shall ensure strict enforcement of the order

All the persons residing in West Tripura District must comply with the aforesaid regulations. Any violation of the aforesaid instructions will invite stern action.

The order will take immediate effect.
