DECLARATION



WHEREAS, it was Notified by Government in the Revenue Department vide Notification NO. F. 09 (01)-REV/ACQ/XXI/20 dated 15-12-2020. that the land/ lands described in the schedule hereto (hereafter referred to as the said land / lands) was / were needed or likely to be needed for the public purpose, namely for the purpose of **extraction/production of Hydrocarbon/Natural Gas at location KUAF under Mohanpur Sub-Division in West Tripura District;**

AND WHEREAS, the Government of Tripura is satisfied, on the basis of the observation made by Administrator of the concerned District that the Rehabilitation and Resettlement Scheme shall not apply under the provision of **Sub-Section 2 of Section 17** of the "Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" (hereinafter referred to as "the Land Acquisition & Rehabilitation Act"), because no displacement of family / families will occur due to proposed acquisition process;

AND WHEREAS, the Requiring Body has deposited the cost of land to be acquired with the Collector;

NOW, THEREFORE, it is hereby Declared under the Provision of **Section 19** of the Land Acquisition & Rehabilitation Act that the said land / lands is / are required for the public purpose, namely for the purpose of **extraction/production of Hydrocarbon/Natural Gas at location KUAF under Mohanpur Sub-Division in West Tripura District.**

The Government is also pleased to direct the Collector, **West Tripura District**, under **Section 20** of the said Act to proceed with the works.

The Land Statement and Plan may be inspected in the Office of the Collector, **West Tripura District** during office hours.
