ORDER UNDER SECTION 144 Cr.PC

Whereas, it has been ordered by the Chief Secretary, Government of Tripura vide order No.F.2(1)-CS/Home/2020 dated 25th May, 2021 that the Corona Day Curfew and Corona Night Curfew will be imposed in the areas of all ULBs including Agartala Municipal Corporation (AMC), Mohanpur Municipal Council, Ranirbazar Municipal Council and Jirania Nagar Panchayat and all other areas of the state including areas of West Tripura District for effective control of COVID-19;

AND

Whereas, the situation has been reviewed in detail by the State Government and it is felt necessary to extend Corona Day Curfew / Corona Night Curfew with more restrictions in the areas of all ULBs including Agartala Municipal Corporation (AMC), Mohanpur Municipal Council, Ranirbazar Municipal Council and Jirania Nagar Panchayat and all other areas of the state including areas of West Tripura in order to contain the spread of COVID-19 pandemic;

AND

Whereas, there is spread of Covid-19 in different parts of the District which poses a major threat to public health, hygiene and safety of the people and it is also felt that unless measures are put in place to contain the spread of the pandemic, there is chance of large scale spread of COVID-19 in the population which is likely to cause loss of human lives;

Now, therefore, I, Sri Raval Hamendra Kumar, IAS, District Magistrate & Collector, West Tripura in exercise of the powers conferred upon me under **section 144 Cr. P.C, 1973** do hereby order the enforcement of the following prohibitory measures:

- A. Imposition of Corona day curfew w.e.f. 5 AM of 26th May, 2021 upto 4 PM of 5th June, 2021 in the jurisdiction of Agartala Mutnicipal Corporation, Mohanpur Municipal Council, Ranirbazar Municipal Council and Jirania Nagar Panchayat.
- B. Corona day curfew in entire West Tripura District except areas under above mentioned Urban Local Bodies from 5 A.M. of 27th May,2021 upto 4 P.M. of 5th June, 2021.
- C. Corona night curfew (from 4 P.M. to 5 A.M.) in all areas under West Tripura District w.e.f. 4 P.M. of 26th May, 2021 to upto 5 A.M. of 6th June, 2021.
- D. Inter district movement of vehicles and people will remain banned till 4 PM of 5th June, 2021 except for exemption indicated in this office order vide no. F.4(11)/DM/W/JDL/Vol-IV/2013/5106-18 dated 19.05.2021.

I. During above mentioned Corona day curfew period (5 A.M. to 4 P.M.) following restrictions will remain in force :-

1. All stand alone shops and commercial establishments dealing with essential items like groceries, vegetables, milk, meat/fish, animal feed/fodder etc. shall remain open only from 6 A.M. to 12 noon. All other shops & commercial establishments will remain closed at all times. Shop owners will ensure social distancing, wearing of masks among customers. Shopping malls and market complexes will remain closed at all times.
2. Vehicles other than government vehicles will be allowed to ply only from 6 A.M. to 12 noon for essential needs. However, this restriction shall not apply to vehicles used for medical needs even after 12 noon.
