HAND OVER OF ITI BUILDING, W. PHAILENG

The Deputy Commissioner, Mamit District vide No.A.14014/73/2012-SWD/Vol-I Dated 19.08.2016 took over the works of construction of ITI Building at W. Phaileng subsequent upon release of 2nd Installment. Upon completion of the project, in pursuance of minute of the meeting on utilization of ITIs under Multi Sectoral Development Programme (MSDP) held in the Chamber of Secretary, Social Welfare Department on 12th June, 2018. Mission Foundation Movement (MFM), Bawngkawn, Aizawl was allowed to utilize ITI Building at W. Phaileng for running special project on Skill Development Training under PMJVK 2.

Memorandum of Understanding/Agreement was signed between DC, Mamit and MFM, Bawngkawn, Aizawl for a period of 2 years which is extendable w.e.f 23rd June, 2018. Consequent upon expiry of the terms of 2 years ie., 22nd June, 2020 the said ITI Building at W. Phaileng is taken over by DC, Mamit and is handed over alongwith all inventories to Secretary, Labour, Employment, Skill Dev & Entrepreneurship Department, Govt. of Mizoram on this day the **29th July, 2020** with immediate effect. Henceforth, the Deputy Commissioner, Mamit District will have no obligation and liabilities whatsoever on ITI, Building at W. Phaileng.
