Office Order:

As part of the containment strategy against the spread of Covid-19 epidemic, pursuant to the guidelines issued by Government of India and Government of Maharashtra, the Aurangabad District Administration has identified Containment Zones for notification/ denotification and implementation of necessary protocols. The zones identified are exclusive of those notified/ de notified by Aurangabad District (Rural) within its boundaries.

The following criteria shall be used for notification/denotification of the Containment Zone, to be demarcated in accordance with Government of Maharashtra letter dated 05/05/2020:

- i An area with the number of active cases of Covid-19 exceeding 5 to be notified
- ii An area with no active cases in the preceding 28 days to be de-notified

The following activities shall be implemented in accordance with the guidelines:

- i Intensive monitoring of the Containment Zone:
- ii Contact tracing.
- iii Home quarantining of individuals based on risk assessment of competent officers
- iv Testing of all cases with Severe Acute Respiratory Infection (SARI), Influenza Like Illness (ILI) and other symptoms specified by MoHFW, Government of India
- v House to house surveillance by special teams constituted for this purpose
- vi Clinical management of all cases as per protocol
- vii Counselling and educating people; and establishing effective communication strategies
- viii Strict perimeter control
- ix. Any other measures prescribed in applicable guidelines/rules



2 The district administration shall notify/de-notify Containment Zones from time to time in accordance with applicable guidelines.


A list of all notified/de-notified Containment Zones shall be hosted on the website of the District Administration and disseminated through mobile applications and dashboards for wider reach and awareness.
