

**Circular No. 08 -ITD of 2018
Dated: 16 .07.2018**

Vide Circular No. 13-GAD of 2018 dated 14.05.2018, all the Officers of the Jammu and Kashmir Administrative service have been enjoined upon to obtain a Digital Signature Certificate (DSC) Type-2, Signing and ensure the possession of Aadhaar Cards, if still not obtained, by or before 25.05.2018 required for e-signing.

However, clarifications have been sought by various Officers whether the payment on account of cost of digital signatures is to be borne by the Government or by the officer themselves. In this regard, the matter was taken up with the General Administration Department and accordingly the said Department vide O.M No.GAD(Ser)APRs/01/2018 dated 25.06.2018 has clarified that the expenditure incurred on account of obtaining digital signatures by any officer shall be borne by the concerned Administrative Departments.

All the concerned Officers are hereby informed to proceed ahead with the completion of Digital Signature Certificate (DSC) without further loss of time.


