This has the reference of the telephonic conversation between our Hon'ble Vice Chancellor and Additional Resident Commissioner, J&K. A number of students from J&K have been recently approaching the University Authorities for admission in Jamia Millia Islamia. It appears that they have applied and appeared in the entrance examination but failed to see the result due to which they could not report in time to complete the admission formalities.
