Subject: - Sanction of Ex-gratia relief to NOKs of deceased persons and compensation of houses damaged due to POK Shelling during 2019.

Whereas, concern Tehsildars have submitted the relief cases of deceased persons, houses damaged due to POK Shelling during ceasefire violations across the LOC for payment of Ex-gratia relief in favour of sufferers under SRE.


Whereas, the relief cases have been placed before the SRE committee held on 09/10/2019 and the committee has approved the relief cases for payment of Ex-gratia relief to the sufferers.

Whereas, an amount of Rupees 2.00 lacs has already been paid in advance out of Red Cross Funds to Noks of deceased persons on loan as recouping basis.

Whereas, as desired by the Divisional Commissioner Jammu vide letter No. 301/793/V/2175-81 dated;- 30-12-2017 that pay the compensation for deceased persons, housing damages, relief for stay at relief camps and displacement etc. at the rates equal to NDRF/SDRF.

Hence, sanction is hereby accorded to the grant of Ex-gratia relief amounting to **Rs. 1240200/- (Rupees Twelve Lacs Forty Thousands and Two Hundred Only)** in favour of deceased persons, Private Property damaged due to POK Shelling during ceasefire violations across the LOC in the year 2019 as per detail given in annexure "A".

The expenditure on this account shall be debit-able **Major Head 2055-Police (SRE), 117- Internal Security, Object Head "Ex-gratia Relief"**.
