Subject: Sanction of Financial Assistance under "Central Scheme" in favour of NOKs of Deceased due to Pak Shelling across the LOC during the current Financial Year 2020-21.

Whereas, the below mentioned person is died due to Pak Shelling during ceasefire violation across the LOC and an amount of Rs 1.00 lac as admissible has already been paid under SRE to the Noks of deceased.

Whereas, as per revised guideline received from Home Deptt. vide Govt. Order No. Home-228 of 2017 dated:-16-03-2017, the cases of the NOKs of the deceased has placed before the meeting of District Level Committee held on 29-05-2020 for providing of financial assistance to victims of terrorist, communal and LWE Violence and Cross Border Firing and Mine/IED blasts on Indian Territory under "Central Scheme" and 01 case of PoK Shelling found eligible.


Whereas, as per the Reveised guidelines issued by Govt. of India Ministry of Home Affairs on 30-10-2019, the Financial Assistance amounting to Rs. 5.00 lacs would be given for each death or permanent incapacitation 50% of the assistance amount will be paid to the victims / beneficiaries saving Bank Account and the remaining 50% will be put in a fixed deposit account for a lock-in period of three years. The interest on the principle amount would be credited directly by the Bank into the beneficiar's saving account on quarterly basis.

Hence, sanction is hereby accorded to the release of financial assistance under "Central Scheme" amounting to **Rs. 05.00 lacs (Rupees Five lacs only)** in favour of the below mentioned **01 No.** of NOK of deceased. The detail of NOK of deceased is as under:
