Whereas, 05 persons died, due to POK Shelling/Cross LOC, Shelling during ceasefire violations on 18-03-2018 at village Dhargloon Tehsil Balakote.

Whereas, as per revised guideline received from Home Deptt. vide Govt. Order No. Home-228 of 2017 dated:-16-03-2017, and due to exigency for providing of ex-gratia relief an amount of Rs. 25.00 lacs has been transferred for providing of financial assistance under the scheme "Central Scheme for assistance to civilian victims/family of victims of terrorist/communal/LWE Violence and Cross Border Firing and Mine/IED blasts on Indian Territory" vide letter No. DCP/Rel/545-46 dated: 18-03-2018 from Account No. 26077 operated by the Asstt. Commissioner, (Rev.) Poonch to CD-847 operated by the Addl. Deputy Commissioner, Poonch as loan on recouping basis for preparation of Fixed Deposit Receipt (MYD) in favour of NOKs of 05 deceased for disbursement to the NOKs of deceased by the Hon'ble Chief Minister on spot.
