Subject: - Measures to prevent the spread of Corona virus – Extension of Red Zone.

ORDER

Whereas, a series of orders/communications stand issued by this office under the provisions of the Epidemic Diseases Act, 1897, the Disaster Management Act, 2005 and the Criminal Procedure Code to contain and check the spread of Corona virus (COVID-19); and,

Whereas, Covid-19 positive cases have been detected in the District, in Poonch town and accordingly, vide this office order No: DMP/PA/7784-94 dated: 28-07-2020 the area involved was declared as Red Zone the adjoining areas as Buffer Zone; and,

Whereas, COVID-19 positive cases have also been detected from parts of Buffer Zone viz Mohalla Panditan near Bali Gym (two cases) & one case in Mohalla Dungus near District Jail, the person running a photostate shop near Court Complex; and,

Whereas, in order to check the further transmission and to break the chain of COVID-19 infection in the area, it has become imperative to take further stringent precautionary measures viz declaring the area/location as Red Zone/Containment zone;

Now, therefore, in view of the above and in the interest of safety and well-being of general public, I, Rahul Yadav, IAS, District Magistrate, Poonch in exercise of powers vested in me under section 144 CrPC, section 34 of the Disaster Management Act 2005 and section 3 of Epidemics Diseases Act, 1897 do hereby order that the Red/Containment zone notified vide this office order No: DMP/PA/7784-94 dated: 28-07-2020 is **extended to following 03 locations** in addition to the locations already mentioned therein: -

1. Mohalla Panditan and its adjoining area covering the lanes – Ghani wali Gali, chowk near Bali Gym and three lanes diverging from that chowk.
2. Part of Mohalla Dungus located between Lakshmi Narayan Temple, District Jail and National Printing Press including road starting from Raina Tiles upto National Printing Press.
3. Street between Imam Bargah and Food Store starting from tri-junction behind GDC upto chowk near Pawan Photostate (inclusive).

The rest of the terms and conditions shall remain the same as mentioned in this office order No. DMP/PA/7784-94 dated: 28-07-2020.
