Subject: - **Measures to prevent the spread of Corona virus – Extension of Red Zone Khanater.**

ORDER

Whereas, a series of orders/communications stand issued by this office under the provisions of the Epidemic Diseases Act, 1897, the Disaster Management Act, 2005 and the Criminal Procedure Code to contain and check the spread of Corona virus (COVID-19); and,

Whereas, Covid-19 positive cases have been detected in the District, in village Khanater accordingly, vide this office Order No: DMP/PA/7991-8000 dated: 02-08-2020 the area involved was declared as Red Zone the adjoining areas as Buffer Zone; and,

Whereas, COVID-19 positive cases have also been detected from parts of Buffer zone viz Mohalla Loharan, W.No.04 and Mohalla Khawajan, W.No.06 of Panchayat Bela Chouhana of village Khanater, the persons being shopkeepers; and,

Whereas, in order to check the further transmission and to break the chain of COVID-19 infections in the area, it has become imperative to take further stringent precautionary measure viz declaring the area/location as Red Zone/Containment Zone;

Now, therefore, in view of the above and in the interest of safety and well-being of general public, I, Rahul Yadav, IAS, District Magistrate, Poonch in exercise of powers vested in me under section 144 CrPC, section 34 of the Disaster Management Act 2005 and section 3 of Epidemics Diseases Act, 1897 do hereby order that **the Red/Containment zone notified vide this office order No: DMP/PA/7991-8000 dated: 02-08-2020 is extended from Khanater Nallah starting from Highway upto Middle School Tanda (Khanater).**


