Subject: - **Measures to prevent the spread of Corona virus – Declaration of Red Zone and Buffer Zone thereof.**

**ORDER**

Whereas, a series of orders/communications stand issued by this office under the provisions of the Epidemic Diseases Act, 1897, the Disaster Management Act, 2005 and the Criminal Procedure Code to contain and check the spread of Corona virus (COVID-19); and,

Whereas, Covid-19 positive cases have been detected in the District, in village Shiendara, Tehsil Haveli. After preliminary contact tracing it has come to the fore that their primary contacts are mainly in Mohalla Kalsan, W.No.9 and 10 of Panchayat Shiendra Upper & Mohalla Sayedan, W.No.02 & 09 of Panchayat Shiendra Lower; and,

Whereas, in order to check the further transmission and to break the chain of COVID-19 infection in the area, it has become imperative to take further stringent precautionary measures viz declaring the area/location as Red Zone/Containment zone and its surrounding areas as Buffer Zones;

Now, therefore, in view of the above and in the interest of safety and well-being of general public, I, Rahul Yadav, IAS, District Magistrate, Poonch in exercise of powers vested in me under section 144 CrPC, section 34 of the Disaster Management Act 2005 and section 3 of Epidemics Diseases Act, 1897 do hereby order as follows: -

1. That the Mohalla Kalsan, W.No.9 and 10 of Panchayat Shiendra Upper & Mohalla Sayedan, W.No.02 & 09 of Panchayat Shiendra Lower of village Shiendara, Tehsil Haveli is hereby declared as **Red Zone**.

2. That the adjoining areas upto 100 metre radius is declared as **Buffer Zone**.
3. That there shall be no inward/outward movement of any person from these areas and inhabitants shall stay at their homes.
4. There shall be complete lockdown in the mentioned areas of **Red Zone**.
5. That there will be no vehicular movement on the inner roads of the area.
6. BDO Lassana shall sanitize the area as per Protocol.
7. BMO Surankote shall thoroughly conduct the process of contact tracing as per Protocol including complete survey of 300 meter radius of area where the aforesaid COVID-19 positive person stayed. Screening and regular health check up of the inhabitants of the surrounding area shall also be ensured.
8. That the following officers shall act as Administrators at the places shown against them: -
  - i) Mr. Sarfraz Ahmed, Lecturer HSS Sawjian (8493839384) shall act as Administrator for Red/Buffer Zone.

Further, the Administrator of the Red Zone and Buffer Zone shall ensure screening the households with the help of Medical department and submit the information to this office on daily basis on 3:00 PM. The Administrator shall ensure the availability of basic facilities including food grains, LPG, medicines in Red Zone through concerning departments.

9. The Hospital/Institutional Quarantine of the contacts shall be ensured by the BMO concerned as per Protocol.
10. Concerned Tehsildar/SHO/TSO shall ensure supply of essential commodities in the area as per laid down Protocol.
11. The contact no. of COVID-19 Control No. 01965-222012, 01965-222079 (Medical Emergency) shall be widely circulated among the population so that the information with regard to any suspect shall be shared by

locals with the authorities. The inhabitants can also call on aforesaid contact numbers in case of any medical emergency.

12. Any person (s)/group/institution found violating the direction mentioned supra shall be booked under the relevant provisions of the law.
