The engagement shall be subject to the following conditions:

1. The engagement is purely on need basis and inextricably linked to the availability of funds and the engagement can be discontinued without any prior notice. Initially the engagement will be for a period of one year and further extension should be subject to the satisfactory performance of the candidate.
2. The candidate shall not claim any sort of absorption as it is purely on temporarily basis. The candidate shall submit an affidavit to this effect.
3. The arrangement can, however be dispensed with before the expiry of period of engagement in case of unsatisfactory performance of the candidate on the laid down parameters.
4. Any candidate found guilty of impersonating or submitting fabricated/ tampered documents/testimonials or making false, incorrect or suppressing material information shall render him/her liable for termination and criminal prosecution under law.
5. The merit list shall remain valid for one year from the date of publication of this notification in the newspaper. In case candidates figuring in the list do not report within 21 days, the candidate figuring in next to the selected list shall called for engagement.
6. The candidate to be engaged shall have to execute an agreement on the stamp paper of Rs. 100.00 (one hundred only) duly attested by the First Class Magistrate, on the provisions of the guidelines of the scheme and the terms and conditions mentioned above.
7. The candidate to be engaged shall give an undertaking to the effect that she is not regularly studying in any Govt./Private Technical/Non technical Institutions.
8. The candidate to be engaged shall give an undertaking to the effect that she is not working in any other department / organization on regular/temporary basis.
9. The candidate shall report for joining to the District Dev Commissioner within 21 days along with following certificates in original at the time of joining
 - i) Qualification certificates/ Marks sheet of all the examination passed.
 - ii) D.O.B certificate as per Matric Diploma.
 - iii) Domicile certificate
 - iv) Character certificate.
